Annual inflation up to 0.2% in the euro area

Up to 0.2% in the EU

Announcement

Starting with the release of data for January 2016, planned for 25 February 2016, the HICP index series will be published with reference year 2015=100, in place of the current reference year 2005=100.



Euro area annual inflation was 0.2% in December 2015, up from 0.1% in November. In December 2014 the rate was -0.2%. **European Union** annual inflation was 0.2% in December 2015, up from 0.1% in November. A year earlier the rate was -0.1%. These figures come from **Eurostat**, **the statistical office of the European Union**.

In December 2015, negative annual rates were observed in twelve Member States. The lowest annual rates were registered in **Bulgaria** (-0.9%), **Romania** (-0.7%), **Cyprus** and **Slovenia** (both -0.6%). The highest annual rates were recorded in **Belgium** (1.4%), **Malta** (1.2%) and **Austria** (1.1%). Compared with November 2015, annual inflation fell in nine Member States, remained stable in three and rose in fifteen.

The largest upward impacts to **euro area** annual inflation came from restaurants & cafés (+0.10 percentage points), tobacco and vegetables (+0.06 pp each), while fuels for transport (-0.40 pp), heating oil (-0.19 pp) and gas (-0.10 pp) had the biggest downward impacts.



Geographical coverage

The **euro area** consists of Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** includes Belgium, Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

The euro area and European Union data refer to the respective country compositions at a specific point in time. New Member States are integrated into the aggregates using a chain index formula.

Data for the United Kingdom for December 2015 were not available in time for publication. Due to this fact the EU totals have been calculated using Eurostat estimates.

Methods and definitions

The **annual rate** measures the change of the Harmonised Indices of Consumer Prices (HICP) between a month and the same month of the previous year, and the **monthly rate** compares the indices between the two latest months.

An **impact** is a measure showing the change in the inflation due to the inclusion of a sub-index. The impact takes account of both the weight and whether the inflation for that sub-index is higher or lower than the all-items inflation rate.

Revisions and timetable

The euro area annual rate for November 2015 has been revised from 0.2% to 0.1% due to revisions in the HICPs of Belgium, the Netherlands and Austria. The revisions in the national indices were not large enough to change the annual rates at the country level, but combined were large enough to change the euro area figure.

A flash estimate of euro area inflation is issued at the end of each reference month. The euro area $\underline{\text{flash estimate for December}}$ 2015, published on 5 January 2016, was 0.2%.

The next flash estimate of euro area inflation with data for January 2016 is scheduled for 29 January 2016.
