Subject: Evaluation statement on the hearing of Mr TIMMERMANS, First Vice-President designate of the European Commission

On 7 October 2014, the Conference of Presidents, following its decision of 18 September 2014, held a meeting open to all Members for the hearing of Mr TIMMERMANS, First Vice-President-designate of the European Commission, who, subject to the positive outcome of the nomination procedure, would be in charge of better regulation, inter-institutional relations, the rule of law, and the Charter of Fundamental Rights.

Prior to the hearing, Parliament had sent the First Vice-President designate a list of written questions to which he replied in writing on 26 September 2014.

The Committee on Legal Affairs scrutinised Mr TIMMERMANS' declaration of interests at its meeting of 25 September 2014, and subsequently informed the President that it had no observations to make.

Mr TIMMERMANS opened the hearing by making a statement in which he referred, inter alia, to the following:

- the historical context of the year 2014 and of European integration;
- the agenda for jobs, growth, fairness and democratic change of Mr JUNCKER, Presidentelect of the European Commission;
- the new operational structure of the European Commission;
- the political guidelines set out by Mr JUNCKER, building on the support of a majority in the European Parliament;
- the necessity to improve and strengthen better regulation, inter-institutional relations, and the constant and comprehensive attention for all aspects of the rule of law and fundamental rights.

During the hearing, Mr TIMMERMANS made specific commitments regarding his future responsibilities, inter alia:

- to ensure the full commitment of the Commission to its special partnership with the European Parliament;
- to ensure that the Commission adopts timely communications in response to Parliament's legislative initiative reports;
- to strengthen inter-institutional relations;

- to oppose parallel and separate institutions for the Euro area, such as an Eurozone parliament;
- to ensure the application of the rule of law and respect for fundamental rights, without hesitation, and using all instruments at the Commission's disposal;
- to conclude the process of accession of the EU to the Convention for the Protection of Human Rights and Fundamental Freedoms of the Council of Europe;
- to focus on transparency and bring forward a proposal for an inter-institutional agreement creating a mandatory lobbyists register covering the Commission, the European Parliament and the Council.

The questions asked during the hearing and the replies given by Mr TIMMERMANS adequately covered the full range of the responsibilities of the First Vice-President designate in steering and coordinating the Commission's work in the areas of better regulation, interinstitutional relations, the rule of law, and the Charter of Fundamental Rights.


Before the end of the hearing, the First Vice-President designate made a brief closing statement in which he reaffirmed his profound sense of urgency of the work that needs to be done in the next five years, and the need to reconnect with the European citizens by delivering better concrete results.

On the basis of the written answers and the responses to the Members present at the hearing, the Conference of Presidents came to the conclusion that Mr TIMMERMANS thoroughly demonstrated his general competence and personal qualifications, such as integrity, independence, professional aptitude and relevant experience, his communication skills and initiative as well as his European commitment, and his commitment to cooperation with Parliament.

The Members of the Conference of Presidents confirmed the positive assessment of the nomination.

The clear outcome of the hearing is that Mr TIMMERMANS gave a thoroughly convincing demonstration of his aptitude to be a member of the College of Commissioners and to carry out competently the specific tasks and responsibilities assigned to him as First Vice-President.

Therefore the Conference of Presidents endorses his nomination.
